PRO TERTIÆ autem, & ultimæ distinctionis partis declaratione, hæc tertia præfigitur thesis: *Mulier, quæ maritum in remotis agentem, mortuum putans, alium ducit, eo redeunte, ad ipsum redire debet, alio dimisso.* Hanc statuit conclusionem Magister, dum sustinet, nullum esse Matrimonium contractum cum eâ, quæ superstiti viro absentis, & existimans eum defunctum, cum alio nupsit; ideòque primo viro redeunti restituenda; quanvis propter bonam fidem non sit adulterii rea.
